You can now pay your taxes and national insurance premiums with your smartphone!

You can make payments via credit card or internet banking at home or outside starting from April 2020.

What you can pay for

- Municipal Taxes/Prefectural Taxes (Normal Collection)
- Fixed Asset Taxes/City Planning Taxes
- Light Motor Vehicle Taxes (Differs by type)
- National Health Insurance Premiums

Things to Note

***Applies only to payment slips with a barcode printed on them.**

Payments exceeding 300,000 yen will not have a barcode printed on the payment slip and cannot be paid via your phone.

*You can no longer pay via your phone if the expiration date printed on your payment slip has passed.

*If you change the method of payment from direct debit payment, please contact us at least 2 weeks before the payment deadline. Our contact information is printed on the back.

Regarding Payment

- Receipts will not be issued. Please check your bank statement or bank book.
- If you pay Light Motor Vehicle Tax via your phone, a tax payment certificate (nozei shomeisho) needed for automobile inspection will not be issued. If you require the certificate, please pay at a bank or convenience store noted on the back of the payment slip.
- You cannot pay via credit card at banks or convenience stores.
- Even if you completed the procedure once, you must continue to complete the process for each payment slip as the money will not be automatically deducted for subsequent payment periods or fiscal years.
- To avoid paying twice, please take note of the day on which you paid. If you have paid twice, the taxes (or health insurance premiums) will be returned but the credit card service fee will not.
- For information regarding credit card points, please contact your credit card company.
